

## Occupational Therapist, Family Support for Children with Disabilities (FSCD) Services Contractor Opportunity

**FSCD Services overview:** Family Support for Children with Disabilities (FSCD) by GRIT provides children with severe disabilities and their families access to intensive services to support learning, development and participation.

The Program introduces new strategies in everyday family routines to promote their child's development and participation including feeding, sleeping, communication, behavior, and more.

Family Support for Children with Disabilities is provided as needed to children as young as two years of age before they access Early Childhood Services by GRIT. Programs may include transition into their grade one year.

**Compensation:** We are looking for compassionate and flexible Occupational Therapists to help build our FSCD services. Contracts are primarily working in the afternoon and early evenings to support family engagement. We offer competitive FSCD Contractor rates.

**Position Overview:** In collaboration with the FSCD Services team and Early Childhood Education Team (PUF), the Occupational Therapist will apply a streamlined evidence-informed approach to support the delivery of services to children/families across settings; utilizing coaching practices in natural environments to build individual and family capacity to accomplish child/family outcomes.

## **Key Responsibilities:**

- Utilizes discipline specific evidence-based (assessment, intervention, and evaluation) practices.
- Provides Caregiver coaching and family capacity building in home, school and community environments.
- Manages a caseload and completes administrative tasks such as consultation notes, service plans and reports.
- Must be flexible, adaptable, and maintain a high level of professionalism at all times.

## Qualifications:

- Education: Bachelor's or Master's Degree in Occupational Therapy
- Registered and in good standing with Alberta College of Occupational Therapists (ACOT).
- AADL authorization status is an asset. If the successful candidate does not have AADL, they will be supported to obtain AADL authorizer status.
- Experience in pediatrics in Occupational Therapy, specific evidence-based practice (assessment, intervention, and evaluation) experience.
